#### **PRESENTATION**

Councilman Green questioned when the audit would be taking place.

John Kelly stated that he is working on adjustments to get ready for the audit.

### POLICE REPORT

Chief Bryson's report included but was not limited to traffic arrests and criminal activity.

Chief Bryson informed the audience there was an individual asking for money outside of local businesses.

Chief Bryson asked the public to not give this individual money and to call the police if they come in to contact with him.

### TOWN MANAGER REPORT

Mr. Chaffinch congratulated Mayor King, Vice-Mayor Green, and Councilwoman Torres on their recent election.

Councilman Dougherty questioned if the street resurfacing project was still projected to start on March 17<sup>th</sup>.

Mr. Chaffinch stated that March 17<sup>th</sup> is the anticipated start date.

## Regular Meeting Minutes

## Town of Camden March 10, 2014

Councilman Casquarelli questioned what is being done about condemned properties inside of town limits.

Mr. Chaffinch stated one property was condemned and then the previous town manager uncondemned it. .

Mr. Eliassen explained that the Town would have to start the process over to condemn the property.

Councilman Casquarelli questioned what is happening with the properties that have delinquent property taxes.

Mr. Eliassen specified that recently, \$23,000 was collected for one property in past due property taxes.

Councilman Casquarelli stated that LED street lighting could possibly save 50% on lighting bills.

### **MAYOR**

Mayor King thanked Judge Ridgely and Senator Bushweller for swearing in the new Council members.

Mayor King recognized Representative Blakey for all of his support.

Mayor King thanked election board members; Jean Bauer, Darlene Bennett, and Becky Fahey.

Mayor King showed his gratitude to Colonel Chaffinch, Jamie, and Amanda for working the election.

Mayor King announced that he is honored to serve as Mayor.

### **NEW BUSINESS**

Appointment of new Planning Commissioner

Mr. Chaffinch stated that he had a meeting with Mayor King in which Mayor King suggested appointing Vicki Rhodes to the Planning Commission.

Mr. Chaffinch made his recommendation to Mayor and Council to appoint Mrs. Rhodes to the Planning Commission.

Motion made by Vice-Mayor Green, seconded by Councilman Casquarelli, to appoint Vicki Rhodes to the Planning Commission. All in favor; none opposed.

Purchase for police department – weapon clearing station

Chief Bryson explained that there was recently an accident at the Police Department.

Chief Bryson presented Mayor and Council with a quote for a mountable clearing station for \$299.95.

Delinquent taxes

Councilman Dougherty explained the Town has recently collected approximately \$23,000 in past due property taxes.

Councilman Dougherty also stated that documentation should start being kept on all properties that have past due property taxes.

Long term savings

Councilman Dougherty stated that he would like to see \$360,000 moved to the savings account, which would give the town six months of expenses in reserve.

Motion made by Councilman Dougherty, seconded by Vice-Mayor Green, to transfer \$360,000 from the general fund money market to the savings money market. All in favor; none opposed. Roll call:

Councilman Casquarelli, yes Vice-Mayor Green, yes Councilman Dougherty, yes Councilwoman Torres, yes Mayor King, yes

Mayor King stated that the town used to have a discount for early payment for property taxes, which he would like to see reinstated.

Councilman Dougherty added that this discount would be reviewed and voted on annually.

Mayor King explained that he would like to further review this topic before moving forward.

Tax Rate

Councilman Dougherty stated that he would like to see a property tax rate decreased that would remain in effect long-term.

Mayor King agreed that he does not want to lower the tax rate and then have to raise it later.

### **PUBLIC COMMENTS**

Bob Shuba stated that Winterbury Woods is a development that is coming three miles outside of Camden town limits. CWSWA is planning on serving this development with sewer and water.

Vice-Mayor Green explained that neither Camden or Wyoming control the CWSWA.

Councilwoman Torres added that the CWSWA board has to vote on this project because it is outside of Camden and Wyoming town limits.

Holly Case stated that running water and sewer three miles outside of town is going to come back on the Camden residents.

Vice-Mayor Green explained that this issue is controlled by the CWSWA board.

### **COUNCIL COMMENTS**

Councilwoman Torres stated that she, Amanda, and Mark from the VFW are looking into an Easter Egg hunt and are seeking donations.

Councilwoman Torres added that she would like to see a facebook page for the Town of Camden to post events and it could be used by the police department.

Regular Meeting Minutes

Councilwoman Torres stated that she would like a committee formed to review the town ordinances.

Vice-Mayor Green congratulated Mayor King and Councilwoman Torres on their recent election.

Councilman Casquarelli thanked Harvest Years for hosting a meet and greet for the candidates.

Mayor King thanked everyone for attending the meeting.

Mayor King explained that public comment is very important.
