PARKING

"ORDINANCE ESTABLISHING PARKING REGULATIONS FOR THE STREETS AND ROADWAYS WITHIN THE LIMITS OF THE TOWN OF CAMDEN AND PENALTIES FOR VIOLATIONS THEROF"

SECTION 1. General Provisions

§ 1.1. Title and scope.

This ordinance shall be known as the "Town of Camden Parking Ordinance," which establishes standards for parking areas covered by this ordinance and is herein sometimes referred to as the "Town Parking Code" or "Code" and shall apply to and include the entire Town of Camden, Delaware.

§ 1.2. Purpose.

This ordinance is intended to protect the public safety, health and welfare, on existing streets, as hereinafter provided, by:

- A. Establishing parking standards for existing streets within the Town of Camden and for safe, thoughtful parking patterns along said streets;
- B. Fixing the parking responsibilities of owners, operators and occupants of all vehicles; and
- C. Providing for administration, enforcement and penalties.
- D. Limit commercial vehicle parking on Town of Camden streets.

§ 1.3. Applicability.

The provisions of the Town Parking Code shall apply to existing streets within the Town of Camden. The provisions are designed to eliminate or prevent substandard parking conditions with respect to vision and to provide adequate requirements for emergency vehicular traffic, eliminate unsafe conditions and overcrowding. Every portion of a street used or intended to be used for parking purposes shall comply with the provisions of this ordinance.

§ 1.4. Interpretation.

The provisions of this ordinance shall be interpreted by the enforcing Police officer from these ordinance's specifications in order to minimize threat to the health, safety and general welfare of the

residents and vehicle owners.

- § 1.5. Effect on other regulations.
 - A. This ordinance does not replace or modify requirements otherwise established for the parking requirements or use of parking areas related thereto.
 - B. Nothing in this ordinance shall be deemed to abolish or impair existing rights or remedies of the Town of Camden or its Police officers or agencies relating to the removal of any vehicle(s) which is deemed unsafe, or in violation with other Town Ordinances or State Law.
 - C. As determined by the Police officer in any case, where a provision of any other ordinance, regulation or statute of the Town of Camden existing on the effective date of this ordinance or hereafter enacted establishes a lower standard for the promotion and protection of the safety and health of the public, the provisions of this ordinance shall govern.
- § 1.6. Word usage and definitions.
 - A. Word usage. Words used in the present tense include the future. The singular includes the plural, and the plural includes the singular. Unless otherwise expressly stated, where terms are not defined under the provisions of this ordinance, they shall have ascribed to them their ordinarily accepted meanings or such as the context herein may imply. Whenever the words "roadway," "motor vehicle," "alley," "highways," "lanes," or "avenues" are used in this ordinance, they shall be construed as though they were followed by the words "or any part thereof."
 - B. As used in this ordinance, the following terms shall have the meanings indicated:
- "Chief of Police" shall mean the Chief of Police of the Town of Camden.
- "Police officer" shall mean any certified police officer of the Town of Camden.
- "Roadway" shall include all streets, alleys, roadways, highways, lanes and avenues within the limits of the Town of Camden.
- "Vehicle" shall mean every device in, upon or by which any person or property is or may be transported or drawn upon a public roadway, excepting devices moved by human power or used exclusively upon stationary rails or tracks and excepting electric trackless trolley coaches and electric personal assistive mobility devices.
- "Motor Vehicle" shall mean any vehicle which is self propelled, except farm tractors and electric personal assistive mobility devices.
- "Commercial Vehicle" is a vehicle of a type required to be registered in the state, used or maintained for the transportation of persons or property for hire, compensation or profit, except taxicabs.
- "Parking permitted except where otherwise prohibited by law" shall mean parking is permitted under this ordinance unless it is prohibited by Title 21 of the Delaware Code.
- "Towing" shall mean the act of removing vehicles from public roadways.

§ Section 1.7. Special Permit Parking:

Special permit parking shall be allowed in the following manner.

- A. A special event or occasion held at a resident's home where several motor vehicles will be present may apply for a special parking permit to allow temporary parking which would not otherwise be permitted on the street(s) near the resident's home.
- B. Only Town of Camden residents may apply for a permit.
- C. A resident must apply at Town Hall at least one week prior to the event.
- D. The Town Clerk will supply a permit application which must be filled out completely with the requested information.
- E. The permit will be forwarded to the Police Department for review and approval.
- F. If approved by the Police Department, the permit will be returned to the administrative office.
- G. The applicant will be notified with regard to the approval or denial of the special parking permit request.
- H. In the case of denial, the applicant will be advised of the reason for the denial.
- I. Only one (1) free special parking permit will be issued per calendar year per Camden residence.
- J. Any subsequent request for a special parking permit will be assessed a \$25.00 fee.
- K. If an event or occasion is held without a special parking permit, parking restrictions and penalties based on this Ordinance will apply.

SECTION 2. Administration and Enforcement

§ 2.1. Administrative liability.

Except as may otherwise be provided by state statute, no police officer, agent or employee of the Town of Camden charged with the enforcement of this ordinance shall be rendered personally liable for any damage that may accrue to persons or property as a result of any act required or permitted in the discharge of duties under this ordinance. No person who institutes or assists in the prosecution of a criminal proceeding under this ordinance shall be liable for damage therefore unless such person acted with actual malice and without reasonable grounds for believing that the person accused or prosecuted was guilty of an unlawful act or omission. Any civil suit brought against any police officer, agent or employee of the Town of Camden as a result of any act required or permitted in the discharge of duties under this ordinance shall be defended by the Town Solicitor until the final determination of the proceedings therein.

§ 2.2. Conflict of interest.

No police officer or employee who has an official duty in connection with the administration and enforcement of this ordinance shall engage in any activity, which is inconsistent with the public interest and the police officer's official duties.

§ 2.3. Records.

A. The Police officer shall keep or cause to be kept records concerning the enforcement of this ordinance's provisions.

§ 2.4. Violations and penalties.

- A. Unlawful acts. It shall be unlawful for any person, firm or corporation to park any motor vehicle in conflict with or in violation of any of the provisions of this ordinance.
- B. **Penalty for violation**. Any person who shall violate any provisions of this ordinance or who fails to comply with any notice issued by a Police officer pursuant to the provisions of this ordinance shall be assessed a civil assessment of \$25.00 if paid within 24 hours or \$30.00 if paid after 24 hours. Handicap parking violation fee is \$100.00 if paid within 24 hours and \$120.00 if paid after 24 hours. This fee is to be collected at the Camden Town Hall.

§ 2.5. Existing violations.

This ordinance shall not affect violations of any other ordinance, code or regulation of the State of Delaware or municipality existing prior to the effective date hereof, and any such violation shall be governed and shall continue to be enforced to the full extent of the law under the provisions of such ordinances, codes or regulations in effect at the time the violation was committed.

SECTION 4. Trailers and Commercial Vehicles

§ 4.1. Trailers and Commercial Vehicles

- A. No trailers or commercial vehicles designed or used for hauling or transportation, and no trailers or commercial vehicles designed or used for dwelling purposes shall be regularly parked or stored in the vicinity of any lot in a residential zone; nor shall any of the same be parked or stored in the vicinity of any lot in a non-residential zone; nor shall any of the same be parked or stored in the vicinity of any lot in a non-residential zone for more than a four (4) hour loading or unloading period. No commercial vehicle shall be parked out-of-doors overnight in a residential zone, provided, however, that said restrictions shall not apply to one (1) commercial motor vehicle of a rated capacity of three-quarter (3/4) ton or less, owned or used by a resident of the premises to go to and from business, which vehicle may be parked or garaged overnight on any premises within a residential zone. Overnight parking shall consist of continuous parking for a duration of six (6) hours between the hours of eleven (11) p.m. and seven (7) a.m. prevailing time. Excluded from these prohibitions are emergency or service vehicles while actually engaged in emergency or service calls.
 - B. Section A shall not apply to vehicles parked in parking spaces approved for such size vehicles by the Town of Camden on a site plan at sites such as hotels, motels, restaurants, truck terminal, or loading docks.
 - C. No commercial vehicles are permitted to park on Town of Camden public streets at anytime, except local deliveries.

1st violation: \$100.00 if paid within 24 hours

\$200.00 if paid after 24 hours

2nd violation: \$200.00 if paid within 24 hours

\$400.00 if paid after 24 hours

- (g) Any person convicted of a violation of this ordinance shall be fined not less than fifty dollars (\$50.00) nor more than two hundred dollars (\$200.00), or upon failure to pay such fine' as shall be imposed, shall be imprisoned for not more than thirty (30) days. Jurisdiction over such violation is hereby vested in Justice of the Peace Court No. 7.
- (h) Each license granted under this ordinance shall be for the sole use and benefit of the licensee to whom it is issued and shall not be transferable. In case of the death of any licensee, his personal representative shall succeed to all rights there under until the date of expiration of the license issued.
- (i) A license granted which specifies the place of business thereby licensed shall not authorize the licensee to carry on any trade, business, pursuit or occupation specified in such license in any other place than the place of business set forth in such license. If a licensee changes the location of his place of business during the period for which the license issued, the license may be transferred to such new location.
- (j) Every person holding a license shall display same in a conspicuous manner in the principal office or place of business of such person. (The license is not transferable.)
- (k) The agents or other representatives or any person, association of persons, firm or corporation who are doing business in the Town shall be personally responsible for the compliance with this ordinance by their principals.
- (l) The applicant must provide a Town of Camden business license application, a true copy of current State of Delaware business license and a true and undated copy of the certificate of liability insurance. If the expiration of the business insurance expires prior to the Town of Camden business license the applicant must provide the Town of Camden and update copy. The penalty for failure to produce an updated copy of the business certificate of insurance is set forth in item (f). The business may also face suspension of business their business license after official notification to applicant.
- (m) A license shall be obtained for each branch establishment or location of the business engaged in as if each branch or establishment or location were a separate business; provided that warehouses and distributing plants used in connection with and incidental to a business licensed under the provisions of this ordinance shall not be deemed to be separate places of business or branch establishments.
- (n) No license shall be required of any person for any mere delivery in the Town of any property purchased or acquired in good faith from another person at his regular place of business outside of the Town where no intent by that person is shown to exist to evade the provisions of this ordinance. Nor shall a license be required of nonresident wholesalers.
- (o) The Town shall issue special permits without the payment of any license fees, to any person or organization for the conduct or operation of a non-profit enterprise, either regularly or temporarily, when it is found that the applicant operates without private profit for a public, charitable, educational, literary, fraternal or religious purpose.
- (p) All police officers duly employed by the Town of Camden shall serve as license agents and shall assist in the enforcement of this ordinance.
- (q) No building permits shall be issued to unlicensed contractors.
- (r) Any person aggrieved by any decision of the Town of Camden shall have the right to a hearing before Mayor and Council by filing a written application within ten (10) days following the effective date of the action or decision rendered. The application shall include a statement of facts relied upon by the applicant to avoid the action or decision complained of.
- (s) Mobile Home Parks
 - (1) Mobile Home Parks must complete application similar to rental license application (see figure 2)
 - (2) The Mobile Home Park fee is based on the number of units per Mobile Home Park with a maximum fee of \$500.00.
 - (3) The Park must submit total approved site to the Town of Camden. The site occupied must have owner information attached to application.
 - (4) The Mobile Home Park is responsible for all tenants' information or application or unpaid fees will be the responsibility of the Mobile Home Park.
- (t) All code enforcement official duly employed by the Town of Camden shall serve as license agent and shall assist with enforcement of the ordinance. This shall also include the Town of Camden Police Department.
- (u) <u>Noise Regulation.</u> No person shall permit any construction to occur between the hours of 8:00 p.m. and 7:00 a.m. prevailing time, which requires outside lighting or which produces noise which would reasonably be expected to disturb any person in the neighborhood.
