## **MINUTES**

## FINANCE REPORT

Account Specialist, Amanda Marlow, reported that the auditors will be at the March Council meeting. Mr. Josiah will be present at the February Council meeting for the quarterly report.

Mrs. Marlow explained that all business licenses and rental licenses are due January 29, 2016 by 4pm.

## POLICE REPORT

Chief Bryson's report included but was not limited to traffic arrests and criminal activity.

Chief Bryson explained that there have been several robberies around Camden and Dover areas. Also he warned residents to be careful with different phone scams that are going after the elderly.

Mayor King added that the recruit is due to graduate Friday, February 12<sup>th</sup>.

Chief Bryson stated that there the new officer will undergo 12 weeks of field training.

Mayor King questioned when the new Tahoe is due to be delivered.

Chief Bryson explained that it should be here in February.

Councilman Dougherty questioned how long a prisoner is detained in our jail cell for.

Chief Bryson replied that it could be anywhere from one hour to 8 hours.

Mayor King added that a prisoner cannot be left in a jail cell without supervision.

Mayor King questioned Chief Bryson if he thinks that the relocation of Troop 3 has added to the robberies that are going on in the area.

Chief Bryson stated that it could be in result of the less police presence.

Mayor King reported that he wants to keep pushing for more police so that there will be a cover shift to help when there is someone detained, to help with police presence, to assist with police safety, and crime.

Vice-Mayor Green agreed that is all for another new police officer to be added to the force.

## TOWN MANAGER REPORT

Mr. Chaffinch reported that the new public works employee started today. He also added that a lot of business and rental license payments were processed today.

Councilman Dougherty stated that he would like the new public works employee to work on the puddle that is at the end of Walmart Drive near Chick-fil-A to see if he can alleviate the water issue.

Councilman Casquarelli asked to have Camden Wyoming Avenue sidewalks cleaned from all of the pebbles from the road work that DelDOT did.

## CAMDEN WYOMING FIRE DEPARTMENT

Mr. Tom Rigsby of the CWFD reported 265 medical calls and 43 fire calls for the month of September 2015.

Mr. Rigsby explained that the new squad is here and is the first new apparatus that the Fire Department has purchased in 20 years and it should be in service this month. He added that it is the only squad in Kent County and one of two for the entire state of Delaware.

Vice-Mayor Green wished Mr. Rigsby and the entire fire department a safe year.

Councilwoman Torres urged everyone to donate to the Camden Wyoming Fire Department.

Mayor King questioned Mr. Rigsby if he saw a lag in response time from the move of Troop 3.

Mr. Rigsby explained that he has not noticed a lag. He added that the fire department has a great relationship with the Camden Police Department.

## CAMDEN WYOMING SEWER & WATER AUTHORITY

Mr. Dan Ridgeley reported that he has been on the CWSWA Board of Directors for almost a year. They currently have a balanced budget and are not planning on raising any rates. He invited everyone to attend the monthly meetings that are the second Tuesday of every month.

Mayor King thanked Mr. Ridgeley for his dedicated service, attendance and his report. He thanked Mr. Ridgeley for his volunteerism and for doing such a fantastic job at no expense to the Town.

Vice-Mayor Green stated that he feels Mr. Woodall seems very qualified for the appointment.

A motion was made by Vice-Mayor Green, seconded by Councilwoman Torres; approve the appointment of Daniel Woodall to the Camden Wyoming Sewer and Water Authority Board of Directors. All in favor; none opposed.

## ADA Ramp Installation Bids

Mr. Chaffinch reported that there were two bids submitted for the ADA Ramp installation, HT Masonry \$30,600 and Mitten Construction for \$44,300. His recommendation was to go with HT Masonry. He added that \$23,500 is still needed to cover the ramps but he is going to ask Representative Yearick and Senator Bushweller for assistance.

Mayor King asked to have the affected residents notified before work is to begin.

A motion was made by Councilman Dougherty, seconded by Vice-Mayor Green; approve the ADA ramp installation bid submitted by HT Masonry and award them the project. Roll call: Mayor King – Yes
