Mayor King thanked everyone for attending the fifth annual Caroling in Camden on Friday, December 2<sup>nd</sup>, 2016. He also wished everyone safe and Merry Christmas and Happy Holidays.

## **MINUTES**

Motion made by Councilwoman Torres, seconded by Councilman Casquarelli, to approve the November 7, 2016 regular meeting minutes. All in favor; none opposed.

Motion made by Councilwoman Torres, seconded by Councilman Dougherty, to approve the November 7, 2016 executive session minutes. All in favor; none opposed.

## **PUBLIC HEARING**

Delaware Community Development Block Grant (CDBG) Program

# Town of Camden December 5, 2016

Albert Biddle explained that this is for consideration by the Town of Camden for the Community Development Block Grant application. The first step is a public hearing to give an overview for those that are unaware that the Town of Camden is considering turning in an application for the CDBG. The Delaware State Housing Authority makes the decision on the funding awards. Most of the money is spent on housing repairs. To be awarded money it must be used on an owner occupied home in low and moderate income households.

Mr. Biddle explained that there are several candidates in the Camden Wyoming area. He added that it would be a better application if the Town of Camden and Town of Wyoming submitted one application together. He explained that each application would need at least 4 candidates.

Mr. Chaffinch added that the last time the Town of Camden submitted an application we joined with the Town of Wyoming and submitted one application together.

Councilwoman Torres questioned if there were residents already on a list.

Mr. Biddle stated that he does have some names already but more people can always be added if they need to be.

Mrs. Burke questioned if churches could get the assistance.

### **NEW BUSINESS**

Delaware Community Development Block Grant Resolutions

A motion was made by Councilwoman Torres, seconded by Vice-Mayor Schock, to approve Resolution 2016-R-03. All in favor; none opposed.

A motion was made by Councilman Dougherty, seconded by Councilman Casquarelli, to approve Resolution 2016-R-04. All in favor; none opposed.

## FINANCE REPORT

Account Specialist Amanda Marlow explained the auditors plan to attend the February Council Meeting to give their report. She added that business and rental licenses will go out December 7<sup>th</sup> and will be due January 30<sup>th</sup>. She detailed that the past due taxes as of the November 2016 Council Meeting was about \$91,000, this month it is about \$78,000.

Mrs. Marlow added that there is a Newells Creek property tax that is delinquent. After she did a review she noticed that this is no longer a taxable property, it has being billed in error and should be adjusted off.

A motion was made by Vice-Mayor Schock, seconded by Councilman Dougherty, for account 1473, Newells Creek Associates LLC, to remove the delinquent balance from the tax roll for the amount of \$3,286.84 because account has been being billed in error and is being billed on another account. All in favor, none opposed.

### CAMDEN WYOMING FIRE DEPARTMENT

Mayor King thanked the Camden Wyoming Fire Department, specifically Tom Rigsby for bringing Santa and Mrs. Claus for Caroling in Camden.

### CAMDEN WYOMING SEWER & WATER AUTHORITY

Mr. Dan Ridgely wanted to bring to the public's attention that there is an aquifer that has dropped significantly in the last decade. There are test being ran to see how this affect this area in the future. He assured Mayor and Council that he will keep them up to date on this matter.

## FRIENDS OF HISTORIC CAMDEN

Mrs. Burke explained that the cookies were donated by the Friends of Historic Camden.

Mayor King thanked Mrs. Burke for her assistance at Caroling in Camden.

## **VFW**

Chaplin Christina Whitman explained that \$1657.82 was collected to assist with providing meals for the Wyoming Methodist Church. She added that they are still doing a collection for clothing on Fridays. She welcomed Mayor and Council to assist with serving meals to the Wyoming Methodist Church shelter during Code Purple.

Mayor King thanked the VFW for their assistance and hot chocolate at Caroling in Camden.
