MINUTES

FINANCE REPORT

Mrs. Yerkes said the Town received \$29,135.70 in RETT. A total of \$1,825,317.08 was collected in taxes and the delinquent tax amount for FY22 is \$12,385.72.

CAMDEN WYOMING SEWER & WATER AUTHORITY

Dan Ridgely said they will be voting on the budget next week.

FRIENDS OF HISTORIC CAMDEN

Dan Ridgely said there was a meeting last month and they are looking into new ways to generate interest for the Historic committee. He added they received one million dollars to go towards the Goggin house and there has been discussion on turning the Goggin house into a museum. Mr. Ridgely said they are looking into dedicating a bench to the late Mr. and Mrs. Chapel.

ZONING ORDINANCE

Dan Ridgely stated there was a meeting with Jennifer Reitz to discuss the current zoning ordinance. There was a discussion on removing the Historic overlay. He added the timeline for completion should be around March of 2023.

POLICE REPORT

Chief Whitney gave a report that included but was not limited to traffic arrests and criminal activity. He added that there were 93 hours of paid overtime and 2 hours of court overtime. He stated that the speed trailer was placed on South Main St for one week and it tracked a total of 118,000 cars traveling on that street.

Vice-Mayor Schock asked what the average speed was.

Chief Whitney stated the average speed was between 32-36 mph.

TOWN MANAGER REPORT

Mr. Scott Jr. said the storm drainpipe was replaced and the project is completed. He added the next storm drainpipe will be replaced in Tamarac. Mr. Scott Jr. said Sunset Village should start construction by the end of the month. He said Jersey Mike's will be going between Chipotle and Five Guys.
