### **NEW BUSINESS**

The Peters Cooper Farm LLC, 3182 Upper King Rd., Map#7-02-103.00-01-06.00-000; The applicant applied for a subdivision.

Chad Carter from Becker Morgan Group, on behalf of The Peters Cooper Farm, is requesting a minor subdivision of this parcel. The parcel is 82.9 acres and is currently zoned C-2 and R-3. The

subdivision would create three lots; a 36.1-acre lot zoned R-3, a 1-acre lot that holds a pump station that services Southside Baptist and Sunset Village, and a 45.8-acre lot that is zoned C-2. The parcel is currently under agricultural use, and the major lot line follows the current zoning line. He added that the parcel does front on both Route 13 and Upper King Road, and after the subdivision, both parcels would then have frontage and have access on those roads.

Commissioner Lanter asked if the pump station will be capable or will it be tied to the other two parcels, and who owns the pump station.

Mr. Carter stated that the pump station has an additional service for future development, and it is owned by the Camden Wyoming Sewer & Water Authority.
